

Privacy Policy

Definition:

Any capitalized terms not defined herein will have the meaning ascribed to them in the GSUTC.

"Personal Data" refers to personal data collected as part of the registration process on the WEBSITE and/or use of the WEBSITE and SOLUTIONS which may include the following elements: Your first name, Your last name, Your e-mail address, Your country of location, Your telephone number and Your company name, Your IP address, data related to Your terminal equipment, data related to Your geolocation, Your identity card and Your passport.

"Privacy Policy" means these terms, including the terms of the Cookies Policy (as detailed in section III below), which govern UPPLY's use of Personal Data provided by USERS and UPPLY's use of Cookies on the WEBSITE.

I) Acceptance and modification of the Privacy Policy

The use of functionalities on the PLATFORM and the SOLUTIONS implies the acceptance of this Privacy Policy.

Thus, the USER undertakes to read this Privacy Policy carefully when accessing the PLATFORM and is invited to print them and keep a copy.

This Privacy Policy is accessible at the bottom of each page of the PLATFORM by means of a hypertext link and can thus be consulted at any time.

The Privacy Policy may be modified and uptaded by UPPLY at any time, in particular to adapt to legislative or regulatory changes.

The applicable Privacy Policy is the one in force at the time of the USER's navigation on the PLATFORM.

II) Personal Data

UPPLY is committed to maintaining high standards of personal data protection.

As part of its activities, UPPLY is required to collect and process Personal Data relating to its USERS and its partners such as suppliers and service providers.

a. USER Information

The USER is informed that the Personal Data processed as part of the process of registering on the WEBSITE and/or using the WEBSITE and SOLUTIONS are subject to computerized processing under the responsibility of UPPLY, acting as data controller.

The USER is informed that the provision of His first name, last name and business e-mail address, country of location, telephone number as well as information relating to its company (except for information identified as optional) is a condition for registration on the WEBSITE. A lack of response will prevent the USER from accessing the SOLUTIONS requested.

b. Fair and transparent collection

UPPLY shall inform its USERS of the processing that concerns them.

c. Lawful and proportionate data processing

When UPPLY processes Personal Data, it does for specific purposes as listed below. These purposes each relate to a legal basis for processing, as required by applicable law.

d. Security, confidentiality and retention period of Personal Data

In accordance with the Personal Data Protection Regulation 2016/679, UPPLY takes all necessary technical and organizational security measures to respect the USER's privacy and protect the Personal Data it communicates in order to keep them confidential.

Among these measures and as an example, Personal Data is stored behind secure networks and is encrypted by UPPLY. In addition, UPPLY uses industry-recognized intrusion test service providers to identify and resolve predictable attack vectors and potential intrusion scenarios.

The USER is informed that the Personal Data will be communicated to Our providers, acting as data processors, who contribute to the achievement of the purposes listed above (hosting, CRM provider, direct messaging service provider, customer service provider, real-time notification provider...) The transfer and the storage of Your Personal Data shall occur in compliance with this Privacy Policy that is framed by contractual clauses that ensure sufficient level of protection of privacy and fundamental rights.

The data processed by UPPLY are located within the European Union on servers of third party hosting service providers of the Site, duly appointed as subcontractors.

If the processing of Your Personal Data by Our providers involve transfers to non-EEA countries that are not recognized by the European Commission as providing an adequate level of data protection according to EEA standards, We will put in place adequate measures, such as by ensuring that the recipient is bound by European Commission standard contractual clauses. You will have the possibility to obtain a copy of these measures by contacting UPPLY.

Please note that the Personal Data that You may be led to communicate to UPPLY online are destined solely for use by persons authorized by UPPLY and in no event shall the data collected on the WEBSITE be sold to third parties.

UPPLY may disclose Your information, including Your Personal Data, to courts, governmental or law enforcement authorities or authorized third parties, if required or permitted by law.

This Personal Data will be kept for as long as necessary for the purposes for which it was obtained as indicated above. In particular, We will retain Personal Data for the duration of the relationship maintained with the USER, and in particular as long as the USER has an active account on the WEBSITE. In case of an ACCOUNT deletion request made by a USER, Personal Data associated with the ACCOUNT will be kept in Our secure archives for five (5) years from the deletion of the ACCOUNT, before being anonymized, in accordance with applicable limation periods. We may also retain Personal Data for longer periods if required by law or if it is desirable in view of Our legal situation (for example with regard to the application of the Terms of Use, applicable limitation periods, disputes or administrative investigations).

The USER undertakes to communicate accurate information. Each USER is fully responsible for

his login data concerning him. Unless proved otherwise, any connection to the WEBSITE or transmission of Personal Data made from the login information of the USER, will be deemed to have been made by the latter.

e. Rights of the data subjects

In accordance with applicable data protection laws, USERS are entitled to request access, rectification and/or erasure of Personal Data concerning them, as well as the right to request that We restrict the processing of their Personal Data.

Each USER is entitled to request the provision of their Personal Data to them or to a third party in machine readable format.

Please note that, where We rely on consent for the use of Your Personal Data, You can withdraw at any time Your consent by manage Your preference in Your account or by sending Your request to UPPLY. You have the right to give Us directives relating to the use of Your Personal Data after Your death.

The USER has the right to object at any time to the processing of his/her Personal Data where We process his/her Personal Data on the basis of Our legitimate interests or for direct marketing purposes.

f. Contacting UPPLY

UPPLY is able to respond to requests for the exercise of the rights of data subjects throughout the processing, in compliance with the conditions and time limits set by the applicable regulations. UPPLY reserves the right to request verification of the USER's identity before taking any action regarding the request. UPPLY also reserves the right to charge a fee where permitted by law, for example if the request is manifestly unfounded or excessive.

Finally, USERS shall have the right to lodge a complaint with the competent supervisory authority,

such as the CNIL for France.

III) Cookie policy

When You browse and/or log on UPPLY.com, Cookies are deposited on Your terminal equipment (computer, mobile phone, tablet etc.) in order to improve Your use of the WEBSITE and increase its performance.
